Frequently Asked Questions

How do I fill out this application?

Prior to starting the application, gather these four pieces of information. It will greatly simplify the effort and time required to complete:

1. The names of owners with 25% or greater ownership equity
2. Photo of the driver's license for each owner
3. Legal name of your practice and your Federal Tax ID number. This must match what's on your federal tax return for tax reporting purposes.
4. The checking account information for the financial institution to which you wish your funds deposited (the Transit Routing Number and DDA/Account Number).

The application will be divided into three main sections:

1. General information about the business
2. Ownership information as required by the USA Patriot Act of 2001, Know Your Customer Rules (From the FinCen - Financial Crimes Enforcement Network) through the Department of Treasury
3. Processing information

When finalized, an authorized signor on behalf of the corporation or entity must sign per the business' corporate resolution.

- Optional Wind River Customer Vault for data storage: \$0.20 per card added/deleted/edited

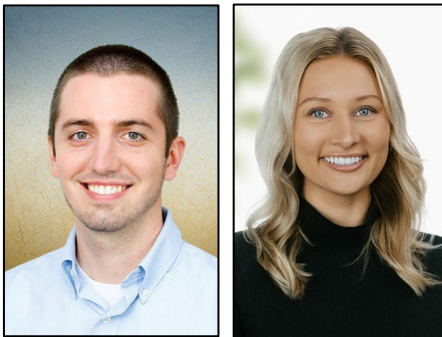

How is data security treated within OneTouch EMR and POPS?

Wind River's integration with OneTouch EMR and POPS has resulted in state-of-the-art security architecture that virtually eliminates difficult PCI technical requirements and comprises the following security elements:

- Secure data collection via POPS hosted payment page means sensitive card information is never stored on your website
- Tokenization securely stores card profiles as alphanumeric hash
- Encryption of all data submitted to the card brands
